The purpose of this committee is to work with the Town Manager to discuss any topics related with public works, if need be. Committee members can meet with public works staff a couple times a year giving them direction as to some things that Council plans to do. For example, when it comes to snow clearing, this committee would give direction on concerns that may arise.

<u>Emergency Plan Committee:</u> Chairperson – K. Hicks, Mayor Gibbons, L. Goodyear and Alternate – N. Norman.

The purpose of this committee to work with the Town Manager to oversee all procedures and compliancy with the Emergency Plan.

<u>Park/Tourism Committee:</u> Chairperson L goodyear, D Gill, K. Hicks and Alternate – B. Goodyear.

3 Members and the Manager to oversee the operation of the parks and discuss any topics dealing with Tourism and Economic Development and report back to Council with any recommendations.
